### Please read the following before completing the application


1. The Lifetime Document/Passport must be registered in the name of the applicant, otherwise the pony will not be inspected. Please check the Lifetime Document/Passport, as incorrect or incomplete applications will be returned.
2. Where a pony has not been tested for HWSD previously a sample for testing may be taken on the day. The fee (stated below) will be incurred by the owner and must be paid with application for classification fee to the CPBS. Applications accompanied by the incorrect fee will be returned.
3. Please read the attached **Procedures and Conditions for Colt/Stallion Inspections for 2020** attached.
4. A pony presented for inspection must be adequately trained, fit and clean to take part in all aspects of the inspection as specified in the **Procedures and Conditions** rules. **ALL DETAILS REQUESTED BELOW MUST BE FILLED IN.**

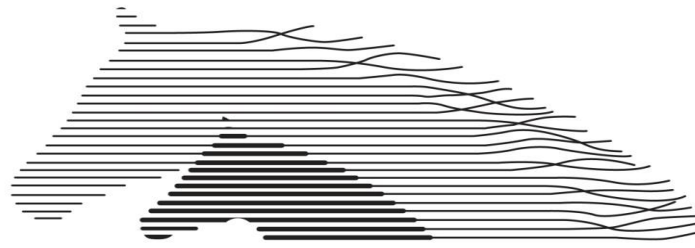
