### **Declaration for Membership of the Council**

He or she will at all times exercise his/her fiduciary duties in compliance with both Companies Act 2014, ([www.irishstatutebook.ie/eli/2014/act/38/enacted/en/html](http://www.irishstatutebook.ie/eli/2014/act/38/enacted/en/html)) and the Charities Governance Code ([www.charitiesregulator.ie/en/information-for-charities/charities-governance-code](http://www.charitiesregulator.ie/en/information-for-charities/charities-governance-code)) and in particular;

- (i) shall act honestly and responsibly in relation to the conduct of the affairs of the company;
- (ii) shall act in accordance with the company's constitution and exercise his or her powers only for the purposes allowed by law;
- (iii) shall not use the company's property, information or opportunities for his or her own or anyone else's benefit;
- (iv) shall understand the standards required to effectively contribute as a member of a company board and which reflect the best practice for a company regulated under the Charities Code of Governance.

The office of the Connemara Pony Breeders' Society and none other shall have the sole rights to publish the minutes of Council Meetings and subcommittee meetings and all other business of the Connemara Pony Breeders' Society. All Council Members and subcommittee members have an absolute obligation to observe this rule.

Council Members shall not publish or broadcast, or allow to be published or broadcast, any material through any form of media including social media that in the opinion of the Council might be defamatory or injurious to any person or to the Society.

Any person elected to serve on the Council of the Society undertakes to respect this honour bestowed upon him or her, and undertakes at all times to treat his or her fellow Council members, members of Society staff and ordinary members of the Society with respect and dignity and, in particular, to conduct himself or herself in a manner that is not threatening or intimidating or menacing, either verbally, physically or mentally or in any other capacity whatsoever.
