Application for Inclusion in Online CPBS Stallion Directory

The Connemara Pony Breeders' Society are updating our Approved Stallion Directory which is available for general access online at www.cpbs.ie under "Pony Search". If you would like your stallion to be included, free of charge, in the Directory please complete and return the attached form. For your stallion to be included please ensure that you complete each section and sign and date the GDPR consent form.

Photograph: The photos taken by the CPBS photographer on the day of inspection are available in the office and may be selected for use – please indicate if you would prefer this option. If you are providing a new photograph the application must be accompanied by one captioned, high quality, side view photo of the pony. The caption must be the registered name of the stallion. Please email photos to aine@cpbs.ie.

Phone screen shots, screen-grabs, poor quality photos (ie. not side view, blurred, not sole subject, etc) or incorrectly labelled photos will not be accepted.

Please note the following:

1. This application must be completed by any registered stallion owner who wishes to have their stallion included in the illustrated *CPBS Stallion Directory*. This directory will be available online and for download.
2. Stallions must be registered with the CPBS (**Class 1 and 2**). Owners and keepers whose stallions have been imported and registered in a CPBS daughter studbook must have completed the CPBS importation procedure <https://cpbs.ie/pony-importation-service/> if they wish their stallion to be included.
3. The applicant **must** be the registered owner of the stallion as recorded with the CPBS.
4. Joint/multiple ownership requires consent from all parties for inclusion in the directory.
5. If the stallion is not standing with the registered owner, both the owner and the keeper are required to give consent for the inclusion of the stallion in the register.
6. The register will include stallions of **Class 1 and Class 2 only**, as classified up to the end of 2021.
7. All stallions must be tested for HWSD. If not HWSD tested please download application for the HWSD test from <http://cpbs.ie/hwsd-hoof-wall-separation-disease-testing-services/>. Please submit this application without delay as untested stallions cannot be included.
8. If the HWSD test was conducted privately (that is, not tested via the CPBS service) the application for the inclusion of a private test result must be completed <https://cpbs.ie/hwsd-private-test-result-application-form/> and returned with this submission together with a **copy** of the private test certificate (this copy will be kept on file in the CPBS office).

Stallion Directory Photograph

This photograph will be used as the stallion's profile photo in the Directory. Ensure the photo is clear, shows the pony in side view and has minimal background detail.
